

# GREENEVILLE HIKING & CYCLING CLUB SIGN UP SHEET WAIVER/RELEASE/HOLD HARMLESS AGREEMENT

By signature below, I affirm that I have full knowledge of the risks associated with the outdoor activities of the GH&CC, and the risks associated with the travel to and from those activities. I understand that serious injuries occasionally occur during participation in outdoor activities, and that participants in outdoor activities occasionally sustain mortal or serious personal injuries, property damage or economic loss as a consequence of not only their own actions, inactions or negligence but the actions, inactions or negligence of others, and that there may be other risks not known to me or not reasonably foreseeable at this time. It is my intention to accept full responsibility for risk of injury, permanent disability or death arising out of my participation in any activity of the GH&CC. I assure the GH&CC that there are no health-related or other reasons or problems which preclude or restrict my participation in any of the activities of the GH&CC.

I further understand and agree that the GH&CC does not have medical personnel available at its activities. I understand and agree that the GH&CC's officers, directors, and members are granted permission by me to authorize emergency medical treatment, if necessary, should I be unable to act on my own behalf. I understand and agree that the GH&CC, its officers, directors, and members assume no responsibility for any injury or damage which might arise out of, or in connection with, any authorized medical treatment.

To the extent permitted by law and knowing the risks of the activities in which the GH&CC participates, I hereby release, waive, forever discharge, covenant not to sue and agree to hold harmless the GH&CC, its officers, directors, and members from any liability whatsoever arising out of my participation in the activities of the GH&CC, or in transit to or from the activities, including but not limited to, medical bills, court costs and attorneys' fees, any damage to my property or the property of others, or to others through my participation in the activities of the GH&CC.

This Release/Hold Harmless Agreement shall remain in full force until revoked by me in writing, and personally delivered to the President of the GH&CC.

I agree that this Release/Hold Harmless Agreement shall be construed in accordance with the laws of the State of Tennessee. If any term or provision of this agreement shall be held illegal, unenforceable, or in conflict with any law governing this agreement, the remaining provisions shall remain in full force and effect.
